During your lifetime you have generously supported the organizations and causes, including Camphill Ghent, that are the most meaningful to you. This support has made a difference. Did you know that you can do something now that will provide for Camphill Ghent after your death? It's called planned giving, and it can be a significant way to advance our vitally important work into the future. By making a provision in your will, you can continue to strengthen Camphill Ghent, after you have gone, as it carries on its unique role of providing a warm and caring community for people in their elder years. We invite you to consider a planned gift now.



LET US COUNT THE WAYS

The beauty of planned giving is there are such a variety of ways to make these gifts possible, many which will not touch your current income.

A bequest, sometimes called a legacy or a devise, can take many forms:

1. **General bequests** transfer a stated sum of money.
2. **Specific bequests** transfer a particular piece of property. If the specific property was disposed of before your death, however, no claim can be made to any other property.

3. **Contingent bequests** require a certain event to occur before distribution. You could bequeath funds to an individual (such as a spouse) provided he or she survives you; if not, the funds would then go to the next beneficiary you name. Many people use contingent bequests to benefit Camphill Ghent, once primary family members have been considered.
4. **Residuary bequests** transfer the “rest, residue, and remainder” of your estate, or a percentage of the residue, after all other bequests, debts, and taxes have been paid.
5. **Unrestricted bequests** allow the beneficiaries to use the assets in whatever way they see fit. For Camphill Ghent, these types of bequests are particularly helpful since they allow us to determine the wisest and most pressing need for the funds at the time we receive them.
6. **Restricted bequests** allow you to specify how the funds are to be used. If you have a special purpose or project in mind, it's best to consult us when you make your will to be certain your intent can be carried out.
7. **Endowed bequests** are managed to provide reliable ongoing program support, coupled with growth designed to maintain the real value of your gift for future generations Camphill Ghent.
